Every part of the program is designed for learning - both actual instructional time and learning of life skills (ex. students keep their own cabins tidy, help with meal set up, and clean up after meals). They have opportunities to challenge themselves to try new things (especially during free time - examples are archery and climbing wall). Each full day of camp (Wed and Thurs), students attend two 2.5 hour classes. These are taught by classroom teachers from the schools (given training and materials when they arrive) and our staff. Camp gives students the opportunity to explore the natural world (and for many, experience the forest for the first time), grow in independence, and make lasting friendships and memories.
