1. ACTION: Statement to Acknowledge Sierra Unified School District (SUSD) Intent to comply with CDPH Health Orders as Written.

The Board will decide whether to officially commit to complying with CDPH Health Orders as stated, which includes the mandate that students will be masked indoors. Students who will not mask, without medical exemption, will not be permitted in the classroom.

4. ACTION: Direction to Suspend Employee Disciplinary Measures Regarding Weekly Testing Pending Availability of Non-Invasive Test Methods

The Board will decide whether to direct that disciplinary actions resulting from refusal to participate in weekly COVID testing be suspended until non-invasive test methods are available. (e.g. saliva sampling)
