The plan shall be presented in a public meeting of the governing board before its adoption in a subsequent meeting.

"There is nothing in statute that prohibits receiving entities from amending a plan at a later date. Therefore, we encourage all receiving entities to get an initial plan approved according to the requirements in California Education Code 41480 and amend the plan, as needed."
