We have engaged our community in a variety of ways to help in the development of the plan to expend ESSER III funds. A large part of the last 2 years have centered around getting a facilities master plan completed to get input from a large number of community groups, staff and teachers, bargaining unit representation, students, parents, advisory committees and other interested parties. This input guided the long-range plan, but also brought into focus the immediate need to update aging HVAC systems in our schools even before COVID-19 changed everything. Now it is critical that these aging systems be replaced, and ESSER III funds can make this possible in the near-term, rather than in 5-10 years that the initial plan laid out.

Another area of community input was with regard to the recovery of learning loss due to COVID-19, distance learning and the loss of instructional time in September-October of 2020 due to the Creek Fire. Sierra Unified School District evaluated its interest holders and the opportunities available for engagement and determined that Civil Rights Groups and Advocates are neither present nor served by the LEA. However, parents, including those of special education, Native American and second language learner student groups, students and staff, teachers, bargaining units, site principals, Education Services Director (special education) and district administration, looked for ways to get back time lost last year, and were instrumental in helping us develop our summer school program that ran from June-August 2021. The funds dedicated to learning loss in ESSER III will allow us to continue to offer a high quality summer school in the future similar to that which

we were able to offer this year. Additionally, the summer program contributed to the efforts in providing extended learning through our Recovery and Resiliency (R & R) program (LCAP Goal 1 Action 5). Last year we established an Independent Studies school, Sierra @ Home, within the district for students K-12, where nearly 1/4 of our students took advantage of the program. Based on input from parents, students and staff, we heard that smaller class sizes were needed if kids were going to return to in-person learning on their regular campus. Offering Sierra @ Home provided the District with the ability to reduce class size, maintain physical-distancing while continuing to provide ongoing instruction that matched the needs of each family.

This plan was made available for public viewing and comment October 4-October 11, 2021 and open to additional public comment on October 11, 2021 at a regular session Board meeting. The School Board approved of the document on October 11, 2021.

#### A description of how the development of the plan was influenced by community input.

School site and district leaders sought out input from parents and students to determine the current needs of a summer school program. Additionally, a survey was sent out (4/15 and 4/19) to all Sierra Unified families, and additionally a Zoom parent forum was hosted to measure interest, need and purpose for summer school. With this input, a summer school was designed in May to begin in June that reflects the current needs, that would replace a credit-recovery only program. Offerings for students in grades K-12 included remediation, extension, original credit and credit recovery.

Staff members commented during engagement meetings for the LCAP (March 15, 2021, March 18, 2021, March 19, 2021, April 16-25, 2021 survey), that smaller class-sizes in the 21-22 academic year would aid in recovery of learning loss, as smaller class sizes allow for more assessment of need at the individual level. With this feedback, we committed to adding additional staff at all school levels to get smaller class sizes for in-person instruction in 2021-22.
